WITNESSETH: That in consideration of the rent herein stated, <u>Lessor</u> does hereby lease to the <u>Lessee</u> premises and improvements thereon, located at 7040 Ramsey Street in or near the city of Fayetteville, Cumberland County, NC for a term of Twenty-four (24) hours, beginning at 12:00 O'clock A.M. and ending at 12:00 O'clock midnight for this date \_\_\_\_\_\_, 20\_\_\_\_

(1) <u>Payment of Rent:</u> Lessee will pay rent to the <u>Building Chairman Lessor's Agent</u> the sum of <u>Nine-Hundred Dollars</u> (<u>\$900.00</u>) in the following increments:

(a) A non-refundable deposit of <u>One-Hundred Dollars (\$100.00)</u> on date of contract.

- (b) The balance of <u>Eight-Hundred Dollars</u> (<u>\$800.00</u>) upon receipt of the club keys. **PLUS**
- (c) A damage deposit of <u>Two-Hundred Fifty Dollars</u> (<u>\$250.00</u>) upon receipt of keys.

(d) Upon surrender of the keys the Lessor and Lessee will conduct an inspection for damages. If there are no damages and the building is clean, the damage deposit and clean-up deposit will be refunded.

(2) <u>Use of premises:</u> Lessee will use the premises for which designed (Business Meetings, Entertainment, Dining, Dancing, Beauty Pageants, Weddings/Receptions, etc.) and will permit nothing to be done on said premises contrary to the policies of insurance, or be contrary to the laws, rules, regulations of any municipal, state or governmental authority, nor permit any unlawful, immoral, or improper activity in or on the premises.

(a) In case Lessee or anyone present on the premises at Lessee's request is guilty of any act which amounts to a public nuisance, or performs any act which results in damage to or destruction of any structure or vegetation on the premises, or removes any fixtures or furnishings; the Lessee will be held fully accountable/liable.

(b) <u>Hold Harmless Agreement:</u> If Lessee desires to have and consume any type of alcoholic beverages (other than beer or unfortified wine) on the premises; a Limited Special Occasion Permit must be obtained from the North Carolina Alcoholic Beverage Control Commission, 400 East Tryon Rd., 4307 Mail Service Center, Raleigh, NC 27699. The fee for the Limited Occasion Permit is \$50.00. Application for the permit, along with the fee, should be submitted to the above at least two weeks prior to the event. <u>All</u> alcoholic beverages must be under the control of the Lessee at all times.

This Agreement further Holds the Cumberland County Shrine Club Harmless of any liability for any act of misconduct involving, alcoholic consumption, fire, personal injury or any other form of liability incurred concerning this lease.
